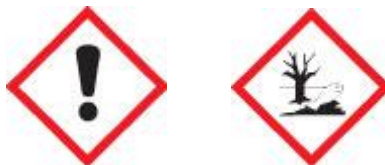

## 6 ACCIDENTAL RELEASE MEASURES
